Local Business Owner as present to request the Board look into updating the local ordinance governing the hours for sale of liquor other than beer and wine on Sundays. He stated that surrounding communities have already updated their ordinances to allow the sale of liquor on Sundays and that he is losing potential business as people leave town to make their purchases. The Board agreed that the ordinance is out of date and directed the Village Attorney to draw up an ordinance allowing the sale of liquor on Sunday to be presented at the January 2018 Board meeting.

Trustee Annen ask that the Board consider Christmas Bonuses for the Village Employees. The suggestion was giving each full-time employee \$125.00 in Chamber Bucks and each part-time employee \$75.00 in Chamber Bucks. There are eight (8) full time employees and two (2) part time, the total for bonuses would be \$1150.00.

Second Reading of Ordinance #798 authorizing general obligation highway allocation fund pledge bonds in the amount not to exceed \$1,200,000.00.

ORDINANCE NO. 798

AN ORDINANCE AUTHORIZING THE ISSUANCE AND SALE BY THE VILLAGE OF HEMINGFORD, NEBRASKA OF ITS GENERAL OBLICAGTION HIGHWAY ALLOCATION FUND PLEDGE BONDS, SERIES 2017, IN ONE OR MORE SERIES IN AN AGGREGATE PRICIPAL AMOUNT OF NOT TO EXCEED ONE MILLIONS TWO HUNDRED THOUSAND DOLLARS (\$1,200,000) TO PAY THE COSTS OF CONSTRUCTING AND INMPROVING CERTAIN STREETS AND OTHER RELATED IMPROVEMENTS OF THE VILLAGE: AUTHORIZING CERTAIN OFFICIALS TO DETERMINE THE FINAL AGGREGATE PRINCIPAL AMOUNT, MATURITIES, RATES, REDEMPTION PROVISIONS, TERMS AND OTHER DETAILS OF SUCH BONDS; PPLEDGING FUNDS RECEIVED FROM THE NEBRASKA HIGHWAY ALLOCATION FUND AND PROVIDING FOR THE LEVY AND COLLECTION OF AN ANNUAL TAX FOR THE PURPOSE OF PAYING THE PRINCIPAL OF, PREMIUM, IF ANY, AND INTEREST ON THE BONDS; DESIGNATING THE BONDS AS QUALFIED TAX-EXEMPT OBLIGATIONS; ADOPTING CERTAIN POST-ISSUANCE TAX COMPLIANCE AND DISCLOSURE POLICIES AND PROCEDURES WITH RESPECT TO THE BONDS; AND AUTHORIZING CERTAIN OTHER DOCUMENTS AND ACTIONS IN CONNECTION THEREWITH.

ORDINANCE NO. 799

AN ORDINANCE OF THE VILLAGE OF HEMINFORD, NEBRASKA AMENDING THE VILLAGE OF HEMINGFORD MUNICIPAL CODE TO PROVIDE FOR A COMMUNITY REDEVELOPMENT AUTHORITY.

Motion by Dannar second by Wacker to waive the three (3) readings of Ordinance number 799

Discussion and Possible action entering into an agreement with Panhandle Area Development District to complete a Blight and Substandard Study to benefit the community and future redevelopment plans within the Village of Hemingford. The cost to the Village for the study would be \$2800.00.

Motion by Dannar second by Wacker to enter into an agreement with Panhandle Area Development District to complete a Blight and Substandard Study at a cost of \$2800.00

Voting Aye: Dannar, Wacker, Hunter and Annen.

Maguire Iron, Inc submitted a contract for the exterior painting of the water tower in the amount of \$44,870.00. The paining of the water tower has been a put on the list of critical corrections that need to be made to the Village water system. The Village water system is inspected annually by the Nebraska Department of Health and Human Services, this item has been noted on the last several years inspections and needs to now be addressed. There was discussion on possible financing options, that could include funds from future grants or loans.

Motion by Dannar second by Wacker to enter into a contract with Maguire Iron, Inc. to clean and repaint the exterior of the water tower to be scheduled for the fall of 2018 at a cost to the Village of \$44,870.00, with 60% due upon completion and the remaining balance due on or before 10/30/19 interest free.

A second item on the list of critical correction with the Nebraska Department of Health and Human Services is the demolition of the black standing water column near the water tower. Estimated cost of demolition with R&C Welding & Fabrication in Gering NE is \$8,700.00.

Motion by Dannar second by Hunter to hire R&C Welding and Fabrication to demolish the old unused water column at a cost to the Village of \$8,700.00.

Update by Kyle Huss on the purchase of a street sweeper. After further investigation it was found that the sweeper Kyle had been looking at for \$16,000.00 would not be appropriate for the village, it is meant to be used on more of a flat smooth surface, such as airport runways, or large parking lots, and would not function well on the streets of Hemingford. Further is was learned that another village had traded that particular sweeper in for a mechanical model,

which is what the Village is in need of. There have been several that Kyle has seen at auction in the past month all costing between \$20,000.00 and \$25,000.00.

Motion by Dannar second by Wacker to approve the purchase of a street sweeper to replace the inoperable one in an amount not to exceed \$25,000.00.
