Discussion and possible action to approve the Special Liquor License (SDL) for Josh Hanson. The Cattle Capital Rodeo Committee is hosting a Cowboy Ball street dance on September 16, 2017. Josh Hanson would like a SDL in order to serve drinks outside during the Street Dance from 3pm to 11pm in the 700 Block of Box Butte Ave. The street will be blocked off with double barricades during the event.

Motion by Dannar and second by Wacker to approve the Special Liquor License (SDL) for Josh Hanson to serve alcohol during the Cowboy Ball Street Dance on September 16, 2017 on the 700 block of Box Butte Ave.
