## Ordinance No. 813

AN ORDINANCE OF THE VILLAGE OF HEMINGFORD, NEBRASKA, AMENDING THE VILLAGE MUNICIPAL CODE SECTION 70.04, RELATING TO TRUCK ROUTES AND PARKING WITHIN THE CORPORATE LIMITS OF THE VILLAGE AND REPEALING ANY OTHER ORDINANCES OR PROVISIONS IN CONFLICT THEREWITH, DIRECTING THE PUBLICATION OF THIS ORDINANCE AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CHAIRMAN AND TRUSTEES OF THE VILLAGE OF HEMINGFORD, BOX BUTTE COUNTY, NEBRASKA:

Chapter 70, Section .04 are replaced in their entirety as follows:

## "§70.04 TRUCK ROUTES AND PARKING.

- (A) It shall be unlawful for any person to operate or cause or permit to be operated or moved any truck, truck/tractor or semi-trailer unit, or any combination thereof (except those classified as recreational vehicles) which exceed 30 feet in length or exceed 20,000 pounds gross vehicle weight on any public street, road, highway or alley within the Village, except those specifically designated as "Truck Routes. Truck Routes shall be designated by signage on the following Streets within the Village: Niobrara Avenue, Roland Street, and Osborn Street. On streets other than Niobrara Avenue, Roland Street, and Osborn Street, such vehicles may be only be operated or moved upon or otherwise used upon streets, roads, highways and alleys of the Village, in the following manner and to such an extent as reasonable necessary for the following purposes:
- (1) To pick up or deliver articles of merchandise or commodities at a location within the city not otherwise prohibited;
  - (2) To refuel or secure repair services upon such vehicle;
  - (3) To park or place such vehicles upon private property, using appropriate curb cuts for access and egress into and out of such private property;
- (4) To park or place such vehicles within authorized truck parking zones or other places not otherwise prohibited;
- (5) To carry on any legitimate business purpose reasonably requiring the use of a truck as described in this section.
- (B) Any departure to or from the Village's Truck Routes, as set forth above, shall be by the most direct routes."
- Section 2. All other code sections, ordinances and parts of ordinances in conflict herewith are repealed; provided, however, this ordinance shall not be construed to effect any rights, liabilities,

duties or causes of action, either criminal or civil, existing or pending at the time when this Ordinance becomes effective.

Section 3. This Ordinance shall become effective upon its passing and approval and publication as according to law.
